this transcript. This will no doubt identify him by the name his
boss Kendrick Moxon calls him: **Philippe Pedersen**. I have not
read the Hutchings version of this deposition because it would
require me to go to their offices on the other side of LA and read
it without taking a copy. In other words, cult lawyer Kendrick
Moxon is using legal harassment to prevent me from commenting on
my own deposition transcript.

My question to you, Angry Gay Pope, is: Are you under the influence of any drugs or medication?

If he's -- If he's got some kind of condition that could even arguably affect his ability to testify, we need to know what it is.

10:45:14 MR. BERRY: First of all, counsel, we have a stipulation. We have agreed that this portion of the deposition relating to his medical information will be deemed confidential and not broadcast in any manner and availa-- and used only for the purposes of this litigation, within the context of this litigation -- meaning in another deposition or in the court.

10:45:41 AGP: I take venlafaxine hydrochloride, which is the generic form of Effexor XR from Wyatt Laboratories for anxiety, and it helps me to stay on an even keel, to remember things, to not get nervous in raid situations, [INAUDIBLE].

10:46:05 AGP: No. No other prescribed brand medications like you said, no. Just Effexor.

10:46:12 MR. MOXON: So that Effexor is the only psychotropic medication you take?

10:46:16 MR. MOXON: How long have you been taking it?

10:46:19 AGP: Uh, at least 8 years.

10:46:23 MR. MOXON: Okay, this ends the confidential portion of the transcript.

10:46:33 MR. MOXON: During the time that you started, as of February of 2008, when you started a -- a -- a relationship with AnonOrange, around or about February of 2008, were you taking any medications that, uh -- affect your thought processes?

10:46:55 MR. BERRY: Objection. Calls for speculation as to what the effects of the medications are. And expert testimony.

10:47:03 AGP: Uh, I've been taking Effexor for eight years and that's all I've been taking. And, also, I didn't meet AnonOrange until months later. It was later than February.

10:47:14 MR. MOXON: As I had indicated, that confidential portion ended, Mr. Berry. So [INAUDIBLE] he's decided to testify on the record outside the confidential portion of it.

10:51:01 MR. MOXON: You were never a -- member of the Church of Scientology, were you?

10:51:07 AGP: No, I have never been a Scientologist.

10:51:11 MR. MOXON: Do you have any family member or relative that was a member of, uh, Scientology?

10:51:15 AGP: No.

10:51:20 MR. MOXON: Did you have any prior relationship at all with Scientology before you started attacking it in -- circa February 2008?

10:51:27 AGP: I've never attacked anyone. That's -- I don't think that is the right way to term that question.

10:51:34 MR. MOXON: Before you started appearing at the Church and --

10:51:37 AGP: Protesting.

10:51:37 MR. MOXON: -- screaming at people in February --

10:51:40 AGP: I thought we agreed last time that you were gonna say "protesting", not "attacking". That's what you said last time.

10:51:45 MR. MOXON: Before February 2008, when you started appearing at churches, screaming at people, did you have any relationship with Scientology?

10:51:53 AGP: No, I had no relationship with the Church of Scientology International.

10:51:56 MR. MOXON: How did you first get with any Scientology entity?

10:52:01 AGP: Um, say that again?

10:52:02 MR. BERRY: Objection. Vague and ambiguous. Confusing.

10:52:03 MR. MOXON: Did you have any relationship with any Scientology entity before you started your screaming at -- at members circa February 2008?

10:52:13 MR. BERRY: Objection to the form of the question.

10:52:15 MR. MOXON: Answer.

10:52:17 AGP: Scientology has so many entities that there is no way for me to know how many there are or where these front groups are, so there's no way that I could accurately tell you in a blanket statement like that.

11:22:03 MR. BERRY: Objection. Calls for speculation.

11:22:07 MR. MOXON: The gathering broke up when you yelled at the people, right?

11:22:11 MR. BERRY: Objection.

11:22:12 MR. MOXON: Answer.

11:22:14 MR. BERRY: The video speaks for itself.

11:22:15 AGP: Yes. You saw what happened.

11:22:19 MR. MOXON: Was your intention to -- disrupt the gathering?

11:22:23 AGP: That's what protests do. Enturbulation. Not disruption. Enturbulation.

11:22:28 MR. MOXON: And how would you define enturbulation?

11:22:30 AGP: Enturbulation is the creation of turbulence.

11:22:33 MR. MOXON: To upset people? Could we generically say enturbulation would be to upset someone?

11:22:39 AGP: Uh, well LRH's definition of enturbulation is the creation of turbulence. My definition might be that enturbulation is more than annoying, but it's less than harassment.

11:22:53 MR. MOXON: That's what you were intending to do?

11:22:54 AGP: Enturbulate.

11:22:56 MR. MOXON: And to break up the -- the gathering of Scientologists.

11:22:59 MR. BERRY: Objection. Asked and answered.

11:23:02 MR. MOXON: Correct?

11:23:04 AGP: Mm. [Shakes his head.] What he said.

11:23:10 MR. MOXON: Answer the question. Part of your purpose was to break up the gathering of Scientologists and make them run inside. [QUES]

11:23:17 MR. BERRY: Objection. Calls for speculation.

11:23:21 MR. MOXON: You can answer.

11:23:22 MR. BERRY: Video speaks for itself.

11:23:23 AGP: Yes, exactly.

11:23:25 MR. MOXON: Answer the question or refuse to answer it.

11:23:28 AGP: I refuse to answer it because the answer is self-evident.

11:23:31 MR. MOXON: Well, it's not an appropriate objection to a question is that the answer is self-evident. As I understand it, the self-evidence of it is that you intended to break up the gathering. Am I correct?

11:25:22 MR. MOXON: Do we mark any for the --

11:26:18 AGP: Yes, I did.

11:26:20 MR. MOXON: And this is your YouTube site, TheEndOfScientology?

11:26:23 AGP: Yes.

11:26:28 MR. MOXON: In fact, were you tipped off by a s-- by a quote "spy" inside Scientology who told you about the, uh, event?

11:26:34 AGP: No.

11:26:36 MR. MOXON: You just made that up.

11:26:38 AGP: Yes.

11:26:50 MR. BERRY: Mr. Moxon, it's nearly an hour and there's not been one question about anything to do with Gilman Hot Springs, Hemet, or AnonOrange's incident that is the basis of this lawsuit.

11:28:48 AGP: I don't know.

11:28:48 MR. MOXON: -- if he's getting any mental health treatment at all?

11:28:50 AGP: No, I don't know.

11:28:58 MR. MOXON: Do you know if AnonOrange, uh, dances? Goes dancing?

11:29:04 AGP: Yes, I -- I think he -- he does. Or he did.

11:29:07 MR. MOXON: Do you know where?

11:29:10 MR. MOXON: How do you know that?

11:30:37 AGP: Oh, I do recall. I just told you that the commissioner said -- He said it to the commissioner, and I was in the room, so I heard it.

11:30:42 MR. MOXON: Really? Okay. I only say this to see if I can refresh your recollection that I was sitting there too and he didn't mention dance lessons.

11:35:58 MR. MOXON: Did AnonOrange seem to, uh, enjoy that incident of the, uh, what you call it, "Scientology Protesters Interrupt Horse-Based IAS Ceremony"?

11:36:12 MR. MOXON: Did -- Did you feel it was a successful raid?

11:36:16 AGP: Yes.

11:36:17 MR. MOXON: Did he feel it was a successful raid?

11:36:19 AGP: Yes.

11:36:31 MR. BERRY: [whispering to Angry Gay Pope] Watch him go.

11:36:33 MR. MOXON: Did it -- Did it matter to you that the, uh, Church's ceremony, IAS ceremony, was broken up?

11:36:45 MR. MOXON: How so?

11:36:48 AGP: Because it was a pep rally, not a ceremony. And we wanted to let those people know what's going on. It was a very educational moment for them if they didn't that David Miscavige beats his staff. It was all an attempt to educate them. And to demonstrate to them that they are not dauntless and defiant.

11:37:09 MR. MOXON: You wanted them to know that they are not doubtless -- dauntless and they are not defiant because they --

11:38:27 MR. MOXON: As a general rule, they seek to avoid you, right?

11:38:29 MR. BERRY: Objection. Calls for speculation.

11:38:32 MR. MOXON: Get away from you.

11:38:33 AGP: Uh --

11:38:33 MR. BERRY: Same objection.

11:38:35 AGP: Your bicycle guards are Scientologists, correct?

11:38:38 MR. MOXON: Can you answer my question?

11:38:39 AGP: Your bicycle guards don't try to get away from me and they are Scientologists. As a general rule, they try and follow me.

11:38:45 MR. MOXON: Okay. Other than the guards. The parishioners of the Church.

11:38:48 AGP: Uh-huh.

11:38:48 MR. MOXON: They try to get away from you, don't they?

11:38:50 AGP: Well, your handlers are parishioners and your handlers follow me everywhere. So you've got guards following me, you've got handlers following me. You know, they are Scientologists. So it's very complex behavior. Scientologists are very complex.

11:39:13 MR. MOXON: Did you ever chalk -- talk to Orange about, uh, whether or not there are services ongoing inside the churches of Scientology where you're performing these raids?

11:39:29 MR. MOXON: Does Orange think it's funny that Scientologists run away when you yell at them?

11:39:36 AGP: I don't know.

11:39:37 MR. MOXON: Has he expressed to you that it's funny? Have you seen him laughing about it?

11:39:42 AGP: He has expressed both laughter and sadness.

11:39:47 MR. MOXON: Sadness and laughter that they run away from him?

11:39:50 AGP: Laughter that they are acting like children, sad that they act like children.

11:39:55 MR. MOXON: When they run away from him. Yes?

11:39:57 AGP: Or-- Or when they act like children in multiple situations, but running away is -- like at Twin Peaks, the RTC --

11:40:05 MR. MOXON: So [INAUDIBLE]

11:40:05 AGP: -- at Twin Peaks.

11:40:06 MR. MOXON: -- the answer is yes or no? Lemme give you the question again.

11:40:10 AGP: Okay.

11:40:58 AGP: No.

11:40:59 MR. MOXON: Did he -- Has he ever had any concern about being punched by a guard or Scientologist?

11:41:05 AGP: He didn't have a concern, he WAS punched by guards.

11:41:08 MR. MOXON: Did you answer my question? Please.

11:41:10 AGP: He never said anything to me about being concerned that that would happen. It did happen.

11:42:56 MR. MOXON: You suggested to him that would be a good idea to get back at Scientology?

11:43:01 AGP: Not to get back at Scientology, to get justice.

11:43:09 MR. MOXON: He told you he was hoping something like that would happen?

11:43:14 AGP: Hoping something like what would happen?

11:43:16 MR. MOXON: Like that he would be arrested so he'd have a claim he could bring.

12:10:31 MR. MOXON: All right. I'm going to show you what was marked in the Orange deposition as Exhibit Number Thirty-One. It's a, uh -- [hands a sheet to Angry Gay Pope] Do you recognize that photograph?

12:10:45 MR. MOXON: That's a photograph of AnonOrange wearing fishnet stockings and holding a sign saying, "I am a Scientologist."

12:11:17 AGP: That would've been in the same raid from Gold Base as, uh -- He was not allowed to go to Gold Base and I may not have taken footage of the Hemet raid. I remember being there, but I don't remember recording anything.

12:12:24 AGP: Yes. That's why it's in Hemet, not Golden Era.

12:12:26 MR. MOXON: So it was after the criminal case was filed.

12:12:28 AGP: I can't remember. I -- I would assume so.

12:12:49 MR. MOXON: Were you with AnonOrange any of the times at Golden Era when he was warned by the police to stay off the property?

12:13:01 AGP: There was one incident, uh, when the CHiPs were patrolling.

12:13:09 MR. MOXON: Highway Patrol?

12:13:10 AGP: Yes. California Highway Patrol.

12:13:14 MR. MOXON: Was that September 20th --

12:13:16 AGP: I can't remember --

12:13:17 MR. MOXON: 2008?

12:13:17 AGP: -- the date. I can't remember the date, but it was 2008.

12:13:20 MR. MOXON: Okay. You were with AnonOrange at Golden Era and some Highway Patrol approached you?

12:13:26 AGP: Yes.

12:13:28 MR. MOXON: Uh, approximately when was that, do you know?

12:13:31 AGP: It was in mid-afternoon.

12:13:33 MR. MOXON: Of what month? What year?

12:13:35 AGP: Oh. It was 2008, uh, before he was attacked, uh, so it must have been before October.

13:15:25 MR. MOXON: Is that -- th-- Is that the incident when you were, uh, arrested for vandalism?

13:15:33 AGP: Y-- I wasn't arrested. No. No, I was not arrested.

13:15:39 MR. MOXON: You were cited?

13:15:39 AGP: Yes, I was cited

13:15:40 MR. MOXON: And you were prosecuted, correct?

13:15:45 MR. MOXON: For vandalism at Golden Era when you were, as you put it, stomping on flowers?

13:16:14 AGP: Because the police refused to show up and I was forced to engage in civil disobedience to make them arrive and enforce Ordinance 884, which is of high importance to the politicians in Riverside.

13:16:39 AGP: Yes.

13:16:32 MR. MOXON: Is that why you pleaded guilty to that vandalism offense?

13:22:27 AGP: I believe I may have recall-- I may have recorded that using my cell phone and then I deleted it.

13:22:33 MR. MOXON: She asked you to leave, right?

13:22:35 AGP: Yes.

13:22:36 MR. MOXON: -- sat down on the couch before you left and said no?

13:22:40 AGP: I don't recall that. I'd need to -- I'd need to watch a video of what happened.

13:22:49 MR. MOXON: So you don't know whether th-- whether you did or didn't -- do that?

13:22:52 MR. BERRY: Objection. Asked and answered.

13:22:56 MR. MOXON: Is that correct?

13:22:57 AGP: I left.

13:22:58 MR. MOXON: You don't know whether or not you sat down on the couch and refused to leave for a time after she's -- told you to leave?

13:23:03 MR. BERRY: Counsel, asked and answered. M-- Why don't you move on?

13:23:06 MR. MOXON: Answer.

13:23:07 AGP: I can't recall. It was such a long time ago. I --

13:23:11 MR. MOXON: Okay.

13:23:11 AGP: I barely remember that one.

13:23:14 MR. MOXON: Were you on drugs at that time?

13:23:16 AGP: No.

13:23:18 MR. MOXON: Medication?

13:23:20 AGP: Now we're right back to where we were. I -- I told you I've taken Effexor for eight years, so I was on Effexor at that time.

13:23:37 AGP: Uh, it has many potentially harmful side effects, of which suicidal ideation could be one.

13:23:45 MR. BERRY: Apparently not, counsel, he's still here.

13:24:24 MR. MOXON: Have you ever had any desire to, uh, punch a Scientologist?

13:24:28 AGP: No.

13:24:29 MR. MOXON: Harm them? Trip them? Do anything to them?

13:24:31 AGP: No.

13:24:32 MR. MOXON: Hurt them in any way?

13:24:33 AGP: No.

13:24:34 MR. MOXON: Have you any desire to hurt yourself?

13:24:37 AGP: I'm sorry, say that again.

13:24:38 MR. MOXON: Have you had any desire to hurt yourself?

13:24:40 AGP: No. You mean, like self-mutilation?

13:24:42 MR. MOXON: That would be one way.

13:24:43 AGP: No.

13:24:46 MR. MOXON: [clears his throat] Uh, do you know where the Church of Scientology mission of Los Feliz is, correct?

13:24:56 AGP: Yes.

13:24:58 MR. MOXON: And you've also been there several times?

13:25:00 AGP: Yes.

13:25:02 MR. MOXON: And -- One time, you went in. You pretended you were interested in a -- in a book? Interested in reading -- Interested in getting information about Scientology?

13:25:45 MR. MOXON: That's not what I asked you. Services aren't performed in the lobby, they're in rooms offs-- off the lobby.

13:30:27 MR. MOXON: And you were initially pretending you were interested in looking at the museum?

13:30:32 MR. MOXON: And when you were told the museum was closed, you and Orange loudly screamed inside the, uh, CCHR lobby, right?

13:30:38 AGP: That's not entirely correct.

13:30:41 MR. MOXON: No [INAUDIBLE]. Fix it.

13:30:45 AGP: We went inside pretending to be interested and we spoke to the young man at the front desk. He told us that the museum was closing, and then we started asking him about body thetans. And he got very uncomfortable asking about body thetans. And eventually he said that we had to leave. And so we began to shout educational slogans as we left.

13:31:06 MR. MOXON: You were screaming inside the lobby?

13:31:08 AGP: Yes.

13:31:09 MR. MOXON: I see.

13:31:10 AGP: Screaming inside the lobby of the anti-psychiatric museum.

13:31:14 MR. MOXON: And you've, uh -- By the way, do you know where, uh, Delphi Academy is in Santa Monica?

13:31:24 AGP: Yes.

13:31:25 MR. MOXON: You've been there several times too, correct?

13:31:28 AGP: Yes.

13:31:29 MR. MOXON: [clears his throat] Why did -- did you go there?

13:31:34 AGP: To educate the Scientologists who run the Delphi Academy.

13:31:38 MR. MOXON: And the children?

13:31:41 AGP: No, the children wouldn't understand.

13:31:44 MR. MOXON: You were also screaming there, correct? When the children were out in the courtyard playing?

13:31:50 AGP: I'm afraid the Delphi Academy is something I'm not going to talk about, because that's pending.

13:31:56 MR. MOXON: Pending?

13:31:56 AGP: It has nothing to do with AnonOrange.

13:31:59 MR. MOXON: What do you mean, "pending"?

13:32:02 AGP: Well, we'll deal with that later. And I'm not gonna talk about it at all. And you can pull any little stunt you want, 'cause it -- I'm not gonna talk about it right now. It has no application to the Orange case. None whatsoever. Makes you look like you're on a fishing expedition. And you're vexatious.

13:33:55 THE VIDEOGRAPHER: The time is 1:33 P.M. We are on the record.

13:34:01 MR. MOXON: When you went to, uh, Delphi Academy in Santa Monica, did you care whether or not you were disrupting their, uh, educational activities at that school with -- by screaming?

13:34:15 AGP: I cared about communicating with the Scientologists.

13:34:23 MR. MOXON: There were children present when you were screaming?

13:34:26 AGP: Yes.

13:34:28 MR. MOXON: Small children, like 4 or 5 years old?

13:34:31 AGP: Yes.

13:34:33 MR. MOXON: Do you think that would scare the children?

13:34:35 AGP: No.

13:34:37 MR. MOXON: To have a -- someone who looks like you screaming at them?

13:34:42 AGP: No, that's why I wore a rainbow shirt and I was talking to the grown-ups only.

13:34:49 MR. MOXON: You were screaming to the children not to believe their, uh, teachers, right?

13:34:53 AGP: Oh, yes, I did tell the children, "Don't let the teachers spy on your parents." I felt it was very important to alert the children of this.

13:35:03 MR. MOXON: You told them their teachers were evil, right?

13:35:06 AGP: Their teachers were spying on them.

13:35:08 MR. MOXON: You told them their teachers were evil?

13:35:10 AGP: I don't remember. And I don't have access to that footage.

13:35:15 MR. MOXON: Did you -- Did you take any footage of that event? Any of those events?

13:35:20 AGP: I have access to the footage from August. I don't have access to the footage from September.

13:35:32 MR. MOXON: So you recorded your, uh, screaming at the staff and children at Delphi in August of 2010?

13:35:40 AGP: Yes.

13:35:42 MR. MOXON: [clears his throat] Do you intend to continue to, uh, do that?

13:35:50 AGP: No.

13:35:51 MR. MOXON: Why?

13:35:53 AGP: She told me not to. The headmistress lady told me not to and I had already, uh -- She told me not to in front of the cops. So I certainly will respect that decision.

13:36:05 MR. MOXON: Did the cops tell you not to come back again?

13:36:09 AGP: The cops said, "Listen to this woman." And she said, "We don't want you to come back." And the cops said, "She doesn't want you to come back."

13:36:19 MR. MOXON: Did the cops tell you not to come back?

13:36:22 AGP: I can't remember.

13:36:23 MR. MOXON: So you have no intention of going back again? Is that what you were [INAUDIBLE]?

13:36:26 AGP: Yes, I have no intention of going back.

13:36:28 MR. MOXON: Is that because you were arrested there last week?

13:36:30 AGP: No.

13:36:31 MR. MOXON: You were arrested, weren't you, last week?

13:36:33 AGP: Yes.

13:36:36 MR. MOXON: Do you know -- Are you -- Have you been charged with a crime?

13:36:40 AGP: I have been charged with misdemeanor, uh -- what was it? -- loitering and disturbing the peace.

13:36:46 MR. MOXON: [clears his throat] Did you have any concern for, uh, scaring these four-year-old children by screaming at, uh, -- screaming near them that their teachers were evil, Scientology was evil, etcetera?

13:37:00 AGP: Yes, things like this have to be handled delicately. That's why, when the children were present, in August, I made it a very kid-friendly protest and said, [waves his right hand] "Good-bye, everybody!" when I was leaving.

13:37:13 MR. MOXON: After you screamed at them you said good-bye very nicely?

13:37:16 AGP: Yes. And the children all said, [waves right hand] "Good-bye!" And the teacher also said, [waves right hand and smiles] "Good-bye!"

13:37:25 MR. MOXON: What's wrong with you?

13:37:27 AGP: What's wrong with me?

13:37:30 MR. BERRY: Do you --

13:37:30 AGP: That's not a question.

13:37:31 MR. MOXON: Do you have a question, counsel? And you're just sitting there smirking and laughing away, you know. Let's move on.

13:37:40 MR. MOXON: Did AnonOrange tell you that, uh, the week before the arrest, that the police threatened to have him arrested if he went on the property of Golden Era?

13:37:56 AGP: Um, w-- what time are we -- What time frame is this?

13:37:59 MR. MOXON: This would be in September of 2008.

13:38:02 AGP: Could you repeat the question?

13:38:03 MR. MOXON: Yeah. Did AnonOrange tell you that the police had warned him again to stay off the property or he'd be arrested?

13:38:08 AGP: No, I don't recall that at all.

13:38:23 MR. MOXON: Did you have any discussion with Orange during 2008 about what the rules were for staying off the property? Rules for these raids.

13:38:33 AGP: W-- I don't recall discussing rules. This was pr--

13:38:36 MR. MOXON: Um, just --

13:38:36 AGP: This was what period?

13:38:37 MR. MOXON: -- kind of an understanding between you --

13:38:38 AGP: Which period is this? Uh --

13:38:39 MR. MOXON: Before the arrest.

13:38:40 AGP: Oh, before the arrest. No.

13:38:47 MR. MOXON: Was there any understanding between you, Anonymous people, as to what the general rules were for staying on or off the property?

13:38:55 AGP: No.

13:39:01 MR. MOXON: But on September 27th, you were at Golden Era, engaged in a raid there, eh?

13:39:06 AGP: Uh --

13:39:07 MR. BERRY: Clarification, counsel. Which year?

13:39:09 MR. MOXON: 2008.

13:39:10 AGP: September 27th, 2008.

13:39:13 MR. MOXON: [whispering] [INAUDIBLE]

13:39:15 AGP: Uh. Uh, I'm not sure about the exact date. I assume you're probably correct.

13:39:22 MR. MOXON: Yeah. Uh, AnonOrange posted a video of a communication he had with the police with the caption "September 27th, 2008 Scientology Operation Creep-Out Second Police Warning", remember that?

13:39:39 AGP: I think he gave it that name. What police was he talking about?

13:39:44 MR. MOXON: Uh, I don't know.

13:39:45 AGP: If it was CHIPS, that was the time I talked about. Um, I -- Do you have a video of that event that I can see to refresh my memory?

13:39:57 MR. MOXON: Yes.

13:40:11 MR. MOXON: Yes. I'll show you, uh, the video.

13:40:25 MR. MOXON: Actually, before I show you the video, let me show you this. This is the screenshots from YouTube and, uh, within the screenshot, on the side, this Operation Creep-Out.

The -- The screenshot says "Scientology Operation Creep-Out Second Police Warning" and, uh, part of it shows a photograph of you, if you look at the second page.

13:40:51 AGP: Let's see, maybe this w-- [looks at photographs] That's a -- foot.

13:41:09 AGP: I think this was CHIPS.

13:41:13 MR. MOXON: Anyway, let's p-- let's play --

13:41:13 AGP: I'm not sure. It's just a foot. Uh --

13:41:17 MR. BERRY: I mean --

13:41:17 AGP: Huh.

13:41:17 MR. BERRY: Can you -- I'm confused, counsel, you're asking me -- asking the witness whether that is his foot in the photograph? Is that what you're asking?

13:41:25 MR. MOXON: [laughs] No.

13:41:27 MR. BERRY: Because I can't see any other indication that he's in the photograph.

13:41:30 MR. MOXON: No. Here, gimme this. [Mr. Berry hands photographs to Mr. Moxon] As I said, on the second page, there's a photograph of you.

13:41:36 AGP: Oh.

13:41:37 MR. BERRY: Ah, the third one down on the right, the second page, okay.

13:41:45 AGP: Well, this is a list of similar videos. This is a list of related videos. Um, so that means that -- Uh, why don't you just show me the video that's there?

13:41:59 [brief sound of a video]

13:42:01 MR. MOXON: All right, we'll play this video, see if you recall, uh, AnonOrange talking to you about this.

13:42:06 AGP: Is this a Orange video?

13:42:08 MR. MOXON: Yes.

13:42:10 [PLAYS VIDEO]

13:43:32 MR. MOXON: [while video is playing] Stop it for a moment.

13:43:34 [video stopped]

13:43:34 AGP: I'm looking to see the police car and I don't see the police car. Does the police car appear?

13:43:39 MR. MOXON: No. So do you remember Orange talking to you about, uh, communicating with a police officer who told him not to trespass on Church property dur-- on September 27th?

13:43:54 AGP: I don't recall that. All I recall is that -- taking that picture on my website that says "Jaywalking Issues". And maybe this was the same -- maybe this was the same incident. I don't know.

13:44:05 MR. MOXON: What did Orange tell you that the police had told him?

13:44:08 MR. BERRY: Objection. Vague as to time.

13:44:12 MR. MOXON: On the incident where you had indicated that the Highway Patrol had said that -- to stay off the property.

13:44:18 AGP: He said that, uh, the police were harassing us and he felt that, uh, Scientology had put the police up to it. And it's all rather academic, because the police have no idea where the easement is.

13:44:30 MR. MOXON: And they were harassing you by keeping you off Scientology property?

13:44:36 AGP: They were trying to force us to walk into the street and then yell at us for being in the street. And we couldn't stand on the curb, and the CHIPS officers kept threatening us with tickets and moving -- CHIPS officer-type harassment, that's all involving traffic and laws regarding how you walk up and down a street regarding which way the traffic is going.

13:45:02 MR. MOXON: And you say th-- they were harassing you because they wouldn't allow you to stand on the curb. You mean they wouldn't let you stand on the Church property?

13:45:10 AGP: Yes, they didn't want us standing on the curb, as I recall, and then when we walked in the street, they said that -- th-- now you're endangering. You can't walk on the street either. The exact same thing happened with Officer Kurylowicz in the pansy stomping. He demanded that we stand on the street or on the curb. Actually, he demanded that we not stand anywhere, which is impossible.

13:45:39 MR. MOXON: So this officer just said in the portion of the video that we played that walking on their property is not acceptable and that, uh, it's trespassing to walk on their property. Did you just hear that?

13:45:50 AGP: Yes.

13:45:51 MR. MOXON: Did you have any discussion with AnonOrange about those issues that day?

13:45:55 AGP: Yes, we discussed how unfair it was that the side of the road is not their property, that's the public easement, and yet we were yelled just for being there, yelled at just for being there.

13:46:04 MR. MOXON: Mm-hmm. So did you decide to just ignore what the police told you and go ahead and g-- go on the property anyway?

13:46:17 AGP: We didn't go on the property. We stood on the, uh, berm and on the, uh, the, uh, curb. And they -- they made all these threats that were empty. We never got ticketed. It was all a big -- It was an attempt to, uh, deny us our right to publicly protest.

13:46:33 MR. MOXON: It wasn't till the next week that, uh, Orange was arrested?

13:46:37 AGP: I think so. But I can't be sure unless I saw a timeline.

13:46:42 MR. MOXON: After the arrest, did you talk to Orange?

13:46:46 AGP: After the arr--

13:46:48 MR. MOXON: You mean --

13:46:48 AGP: Well --

13:46:49 MR. MOXON: Right after the arrest, --

13:46:50 AGP: Oh.

13:46:50 MR. MOXON: -- did you talk to him?

13:46:52 AGP: Lemme think back. No.

13:46:55 MR. BERRY: Is that, --

13:46:56 AGP: He was in jail.

13:46:56 MR. BERRY: -- counsel, are we talking about the arrest that is the actual subject of the Orange lawsuit? That arrest?

13:47:03 MR. MOXON: The arrest at Golden Era.

13:47:04 AGP: Right, because he's been arrested several times and not charged. The Golden Era arrest. I didn't talk to him immediately. He was in jail. And then, after he got out, he called me.

13:47:15 MR. MOXON: What did he tell you?

13:47:16 AGP: He told me what prison was like.

13:47:23 MR. MOXON: Did he tell you he'd been arrested for going on their property? Trespassing?

13:47:28 AGP: No. We didn't believe he was trespassing. We had -- But we weren't certain, and later we found out he wasn't.

13:47:35 MR. MOXON: What do you mean, you weren't certain? Why not?

13:47:37 AGP: Because the easement is a complex issue there.

13:47:40 MR. MOXON: Mm-hmm. So you were debating whether or not it was Church property?

13:47:47 AGP: No, we were angry that he had been attacked in an open field.

13:47:53 MR. MOXON: But -- When you talk about the easement, you had a dis-- you allegedly had a discussion with him immediately after he was arrested about the easement?

13:47:59 AGP: No.

13:48:00 MR. BERRY: Objection.

13:48:01 MR. MOXON: Did you have dis--

13:48:01 MR. BERRY: Mischaracterizes his testimony.

13:48:03 MR. MOXON: I'm asking, did you have a discussion with Orange after his arrest concerning whether or not there is some easement?

13:48:13 AGP: No, because immediately after his arrest, he was in jail and I couldn't talk to him.

13:48:16 MR. MOXON: I know, but you did talk to him. I'm talking about the conversation you had with him.

13:48:20 AGP: Oh, after he got out of jail?

13:48:22 MR. MOXON: I don't -- I don't know whether it was got after jail or after he called you, but he -- yes, after he got out of jail. You had --

13:48:27 AGP: He --

13:48:27 MR. MOXON: You said you had a discussion with him about the easement, correct?

13:48:29 AGP: Yes. In the weeks following, we had discussions about the easement.

13:48:33 MR. MOXON: Mm-hmm. And did he assert to you that he didn't feel the arrest was appropriate because, even though he was on Church property, there is an easement?

13:48:46 AGP: We assumed he was not on Church property, and your "No Trespassing" signs were illegal.

13:48:52 MR. MOXON: So he -- he said there were trespassing signs, but they were illegal because there's an easement?

13:48:57 AGP: "No Trespassing" signs are illegal because they are too small, the lettering is too small, and they do not cite the trespassing ordinance that they are purported to, you know, warn about.

13:49:06 MR. MOXON: Which trespa-- "No Trespassing" signs did he talk to you about?

13:49:11 AGP: All of your "No Trespassing" signs are illegal, as I determined --

13:49:13 MR. MOXON: No, --

13:49:13 AGP: -- myself.

13:49:13 MR. MOXON: -- I mean, which ones did he talk to you about?

13:49:16 AGP: The "No Trespassing" signs on the area where he was.

13:49:21 MR. MOXON: So he -- Did he describe them to you?

13:49:23 AGP: No, I've seen them myself many times and photographed them.

13:49:27 MR. MOXON: Prior to this incident?

13:49:28 AGP: Yes.

13:49:30 MR. MOXON: Did you ever talk to Orange about the "No Trespassing" signs that were there prior to the incident, prior to the arrest?

13:49:38 AGP: Yes, we discussed the fact that they were illegal, and he told me why they were illegal.

13:49:42 MR. MOXON: What did he say?

13:49:43 AGP: He told me what I just told you.

13:49:45 MR. MOXON: That the s-- That the lettering was too small, they didn't have a correct ordinance on them, something like that?

13:49:49 AGP: Yes, and they have to be -- they have to be a s-- The entire sign has to be a certain size, the letters have to be a certain size, and they have to have the legal ordinance mentioned. None of yours do that, and some of them are even illegible.

13:50:51 AGP: Anyone who read my website, because I had an exhibit on it.

13:50:55 MR. MOXON: I'm talking about before the, uh, arrest.

13:50:59 AGP: I don't think so. No. To the best of my knowledge, I don't recollect that.

13:51:03 MR. MOXON: Where were you when you and Orange were having this discussion about the "No Trespassing" signs before the arrest?

13:51:11 AGP: Uh, I don't know. At mo-- We had probably more than one, talking on the phone.

13:51:18 MR. MOXON: Any, uh -- Any discussions while you were at Golden Era, you know, prior -- one of the prior p-- raids?

13:51:25 AGP: Possibly, but unless that was recorded on video, I -- To the best of my recollection, I can't recall a sp-- specific incident.

13:51:34 MR. MOXON: Do you have any, uh, recollection of you and Orange looking at the "No Trespassing" signs and him saying, "See, this is what I mean. They're -- They're not the right lettering" or something like that?

13:51:44 AGP: No. I remember photographing them all, because they were all different.

13:51:50 MR. MOXON: When, uh, did you take the photographs?

13:51:53 AGP: Uh, the first couple of Gold Base raids.

13:51:57 MR. MOXON: So this would've --

13:51:57 MR. MOXON: -- been early 2008 or --

13:52:40 AGP: Because there were so many of them and they didn't look like "No Trespassing" signs I had seen before.

13:52:45 MR. MOXON: You mean they were -- they were different than the type you had seen before?

13:52:49 AGP: Yes.

13:52:52 MR. MOXON: And so, AnonOrange did some research, did he, on "No Trespassing" signs or -- or what?

13:52:58 MR. MOXON: And he -- What -- And he -- And he elucidated to you that he didn't think the lettering was appropriate and whatnot?

13:53:06 AGP: Yes, he told me they were all illegal.

13:53:08 MR. MOXON: Mm-hmm. Did you suggest to him, "You better abide by them anyway"?

13:53:16 AGP: I didn't say one thing about it.

13:55:17 AGP: Uh, I have a restraining order, uh, that I do not go near her, her place of work, or her home, within fifty yards.

13:56:57 AGP: Fr-- AnonOrange, François Orange.

13:57:04 MR. MOXON: How did Susan Elliott -- Oh, we -- Didn't you also get the footage from, uh, Orange's camera?

13:57:12 AGP: Isn't he one of the people I mentioned?

13:57:13 MR. MOXON: No. Oh, --

13:57:14 AGP: No.

13:57:14 MR. MOXON: -- Orange, okay. Yeah, got his. All right, how did you get his footage?

13:57:17 AGP: I believe he gave it to me later on, uh, a CD.

13:57:22 MR. MOXON: So he didn't give you the, uh, chip out of his camera?

13:57:41 AGP: -- foota-- How I physically got it, I don't recall. He may have given it to me physically, I may have copied it off -- I -- He probably gave it to me on a DVD. That is -- That's something you'll have to ask AnonOrange because I don't remember now.

13:57:56 AGP: It's possible.

13:57:58 MR. MOXON: Sure Mr. Berry didn't give you the chip out of his -- Orange's camera?

13:58:22 AGP: Uh, if it was a chip, I gave it back. If it's a DVD, I might still have it. Maybe not. I don't know.

13:58:34 AGP: No, I volunteered. I told you that last time. This is all a r-- a com-- complete duplication of what we did last time. I've answered these questions before.

13:59:23 MR. MOXON: So the decision to, uh, cut that out was made by you jointly? Cut out some of the swearing by Orange?

13:59:31 AGP: Yes.

13:59:32 MR. MOXON: That's when he was -- when the guards told him he was trespassing and he said, "Fuck you", right?

13:59:36 AGP: Yes.

13:59:40 MR. MOXON: Did you provide him with, uh, footage to give to the prosecutors?

13:59:46 AGP: Did I provide him?

13:59:48 MR. MOXON: Yeah.

13:59:48 AGP: I edited a YouTube video for the purposes of YouTube and, to be helpful, he personally gave that footage to the prosecutors without them having asked for it.

13:59:57 MR. MOXON: The one off YouTube?

13:59:58 AGP: Yes.

14:00:00 MR. MOXON: But that was edited to take out some of the, uh, swearing, right?

14:00:06 AGP: Yes, that was edited to take out some of the swearing because that's YouTube, and YouTube is not a court of law. When the police demanded the evidence of him, both he and I had delivered that video to you and, although I couldn't find it on that list, I told you which video that was. I sent an email to [points with his left thumb] him telling you which file that was. And that file has been provided to you uned-- It was provided to the police, unedited, when the police requested it.

14:00:33 MR. MOXON: The police subpoenaed you for evidence?

14:00:35 AGP: What?

14:00:35 MR. MOXON: Did the police subpoena you for evidence?

14:00:38 AGP: No, but, uh, you asked for, uh, -- You subpoenaed me for evidence.

14:00:44 MR. MOXON: Okay. Did the police subpoena you for evidence?

14:00:46 AGP: I must've misspoken. When you wanted the twenty-seven gigs of information, --

14:00:51 MR. MOXON: I'm talk-- My question is did the --

14:00:52 AGP: No.

14:00:52 MR. MOXON: -- police

14:00:52 AGP: No.

14:00:52 MR. MOXON: -- subpoena you?

14:00:53 AGP: No.

14:00:54 MR. MOXON: So what was given to the police, however, was the YouTube video that you edited, right?

14:00:59 MR. BERRY: Calls for speculation.

14:01:01 AGP: What was -- What was given to the police was the full edit-- f-- full unedited footage which it --

14:01:08 AGP: Because, uh, Orange told me that he gave them the unedited footage when they demanded it, and I've -- I've done the same thing.

14:03:20 WOMAN'S VOICE: I'm sorry, what was that?

14:03:21 MR. MOXON: Where he lives. Do you know anything about him?

14:03:25 AGP: He's a middle-aged white man.

14:03:31 MR. MOXON: How did you get Susan Elliott's footage?

14:03:34 AGP: I believe, uh, she mailed me a DVD. I still have that DVD. I think -- I believe I still have that DVD, to the best of my recollection. [reaches for tissues and dries his hands].

14:06:08 AGP: Uh, yes.

14:06:09 MR. MOXON: And that's -- that's a pretty typical response by Orange, isn't it?

14:06:16 AGP: I don't what you mean by "a typical response". If someone --

14:06:18 MR. MOXON: He says that to security guards pretty often. Curses at security guards. Church security guards.

14:06:25 AGP: I've only been with him on some raids. I --

14:06:28 MR. MOXON: Have you seen him curse at Church security guards?

14:06:30 AGP: Yes.

14:06:32 MR. MOXON: Why does he do that?

14:06:34 AGP: You'd have to ask him.

14:06:38 MR. MOXON: So did it seem --

14:06:38 [loud snapping sound]

14:06:38 MR. MOXON: -- seem to you like he's kinda baiting them or sus-- or what?

14:06:44 AGP: I -- I don't know. It would just be supposition from my part.

14:06:50 MR. MOXON: Did he ever talk to you about why he does that?

14:06:53 AGP: Uh, he s-- at best has said that he, uh, should not do that, and he regrets it.

14:07:01 MR. MOXON: Why?

14:07:03 AGP: Because it, uh, is rude.

14:07:07 MR. MOXON: Doesn't he want to enturbulate them?

14:07:09 AGP: Remember w-- um, what my definition of enturbulation was? It's like, more than annoying, but it's less than harassment. So I just enturbulate. So I keep it -- keep it clean.

14:07:26 MR. MOXON: He goes beyond your level, though, doesn't he? He -- He gets in people's face more than you? In the sense --

14:07:32 AGP: That's a --

14:07:32 MR. MOXON: -- of trying to upset them more than you do.

14:07:35 AGP: I don't know. That would be a judgment call. You'd need to ask the people we talked to.

14:07:38 MR. MOXON: Yeah, I'm asking you for your judgment. Does it seem to you like he tries to annoy them even more than you do?

14:07:46 MR. BERRY: Objection. Calls for speculation.

14:07:49 AGP: I don't know of an annoyance sort of tone scale that we can measure levels of enturbulation on, uh.

14:08:32 MR. MOXON: -- harassing, right?

14:08:32 AGP: Yes.

14:08:33 MR. MOXON: Okay. So when you're swearing at people, telling them "Fuck you", for example, would you consider that to be more than annoying and into the level of harassment?

14:08:47 MR. MOXON: I mean, that's kind of fighting words sometimes, isn't it?

14:08:50 MR. BERRY: Objection.

14:08:51 AGP: [claps his hands] Fighting is --

14:08:52 MR. BERRY: Calls for speculation.

14:08:53 AGP: He's the one who's been punched. [reaches for a tissue] And you're saying he has fighting words?

14:09:01 MR. BERRY: [to Angry Gay Pope] [whispering] Don't debate with him.

14:09:02 MR. MOXON: We'll take a break for a moment.

14:09:05 THE VIDEOGRAPHER: The time is 2:09 P.M. We are off the record.

14:22:59 MR. MOXON: Do you know if, after all the warnings that, uh, Orange received about trespassing, prior to his arrest, he must've thought he'd be arrested eventually, right?

14:23:14 MR. MOXON: Do you know?

14:23:15 AGP: No, I have no idea.

14:23:17 MR. MOXON: Did he ever tell you he was concerned about getting arrested at --someday?

14:23:22 AGP: No.

14:23:23 MR. MOXON: Did he ever tell you he hoped he'd get arrested?

14:26:04 AGP: I'm not going to tell you. That is privileged -- That is a, like a journalistic privilege.
